

## **REPLACEMENT OF DIRECTOR**

For purposes of the provisions of item V of the Agenda contained in the call to the General Ordinary and Extraordinary Shareholders' Meeting of Vista Oil & Gas, S.A.B. de C.V. (the "<u>Company</u>") to be held at 10:00 hours of April 26, 2022, in Mexico City, United Mexican States, at the corporate domicile of the Company, in the meeting room located at Torre Virreyes, Pedregal No. 24, 24th Floor, Colonia Molino del Rey, Zip Code 11040, Miguel Hidalgo (the "<u>Annual Shareholders' Meeting</u>"), announced by the Company on March 16, 2022, we hereby announce that it is intended to submit for consideration of the Company's shareholders gathered at the Annual Shareholders' Meeting, the substitution of certain member of the Board of Directors of the Company as follows:

Subject to the approval of the shareholders, Mr. Mark Bly will be replaced as a member of the board of directors of the Company by Mr. Gérard Martellozo. Such substitution will have immediate effect as of the approval of the shareholders at the Annual Shareholders' Meeting. The foregoing, in the understanding that Mr. Gérard Martellozo may, at any time in the future, provide evidence of his status as independent person to the Company and subject to the approval of the shareholders at any subsequent ordinary meeting, Mr. Gérard Martellozo shall be deemed as of such time, as an independent person and member of the board of directors of the Company, in accordance with Articles 24 second paragraph and 26 of the Securities Market Law, and Article Eighteenth, item (vii) of the Company's bylaws.

Gérard Martellozo developed his career in Schlumberger for 40 years, from where he retired in 2019 when being Vice President of Human Resources (HR) worldwide based in London. Prior to assuming this position on 2014, he was Senior Advisor to the chief executive officer of Schlumberger, based in Houston, Texas, United States.

Gérard joined Schlumberger in 1979 after completing a Masters of Engineering at the Ecole Nationale Superieure de l'Aeronautique et de l'Espace (Sup'Aero), France. He began his oilfield career as a wireline field engineer, quickly progressing into operations management with assignments in Spain, Italy, France, Nigeria, Algeria and Venezuela. After his experience in industry operating matters. He then transitioned into Human Resources (HR), and during the next twenty years worked with most of the company's oilfield services business sectors. From 2010 to 2012 he was HR Director of the company's drilling group, and during this time was responsible for integrating the organizations of several major oilfield services companies purchased by Schlumberger including Cameron, Smith, M-I and Geoservices.

Gérard Martellozo is currently the Chairman of the Board for the Schlumberger Foundation. Before that, he joined the board of the Foundation in March 2014 to continue to lend his support to the Schlumberger long-term commitment to promoting women in technology in the world at large. He was also co-founder of Partnerjob.com, for which he served as treasurer from 2003 to its sale in 2017 to NetExpat.
