

CALL FOR A HOLDERS' MEETING OF THE WARRANTS IDENTIFIED WITH TICKER SYMBOL "VTW408A-EC001"

As provided by Article 68 of the Mexican Securities Market Law (*Ley del Mercado de Valores*), Article 218 of the Mexican General Law of Negotiable Instrument and Credit Transactions (*Ley General de Títulos y Operaciones de Crédito*), and in accordance with Clause Nineteenth of the warrants issuance indenture (the "<u>Issuance Indenture</u>"), as well as the global certificate comprising the issuance of the warrants identified with the ticker symbol "VTW408A-EC001" (the "<u>Global Certificate</u>" and the "<u>Warrants</u>", respectively), issued by Vista Energy, S.A.B. de C.V. (formerly Vista Oil & Gas, S.A.B. de C.V.) - **II.** Appointment of delegates to comply with and, as appropriate, formalize the resolutions adopted at the Holders' Meeting.
